Purchase Policy

- 2.2. All prices listed on the Preowned Platform include a major service
- 2.3. All Compressors purchased and checked by NESSCO PRESSURE SYSTEMS service technicians will receive an Asset sticker that allows the purchaser to find all information and documents regarding that Asset.

Shipping and Delivery Policy

- 2.2. Nessco Pressure Systems will deliver your purchase only once an industry check has been completed on the compressor.
- 2.2. Pick up is also available from the Nessco Pressure Systems warehouse. NESSCO PRESSURE SYSTEMS does not supply vehicle for pick up.

Exchange & Returns Policy for purchases

2.4. We do not offer a satisfaction guarantee on products or refunds for change of mind; however, NESSCO PRESSURE SYSTEMS will always endeavor to keep you happy and satisfied. This warranty only applies to unused and undamaged goods.

Risk & liability

2.5. We accept advertisements from Sellers in good faith. Advertisements on the Preowned Platform for Products are prepared by Sellers who are unrelated to us. We take no responsibility for the accuracy of



price information or specifications of any Products advertised and/or sold. We take all reasonable precautions to only host accurate information on the Preowned Platform. It is your responsibility to verify any information on the Site and to investigate for yourself the condition, quality and suitability of any products advertised on the Preowned Platform

3 All Sellers

- 3.1. By placing an advertisement on the Preowned Platform, all Sellers accept and must conduct themselves in accordance with these Terms and Conditions. It is a Seller's responsibility to ensure they comply with applicable Terms and Conditions.
- 3.1.1 NESSCO PRESSURE SYSTEMS does not purchase the secondhand unit that has been submitted.

Advertisement Policy

- 3.2. Once the seller submits a product listing, NESSCO PRESSURE SYSTEMS will review and determine if this product meets the company standards.
- 3.3. NESSCO PRESSURE SYSTEMS will then contact the seller via the contact details provided to organize a suitable time for a service technician to do a full industry check on the compressor for sale.
- 3.4. NESSCO PRESSURE SYSTEMS has the right to decline a sale of an item should the item for sale not meet the standards.
- 3.4.1 Any failures or repairs that are found during the inspection will be presented to the seller. It is the seller's responsibility to have these rectified. NESSCO PRESSURE SYSTEMS will not cover or pay for any repairs required following the inspection unless a PO or upfront payment is provided by the seller.

Content of advertisement

- 3.5. All advertisements must relate to air compressors. We may reject advertisements that are not relevant to these areas of interest and reserves the right to cancel/and/or amend such advertisements, without notice.
- 3.6. We may withdraw or alter the advertisement or material you send us if it is deemed to be inappropriate, incorrect or not in keeping with the Site's style standards and tone.
- 3.7. Advertisements on the Preowned Platform may only include text descriptions, graphics, pictures and other content relevant to the sale of that Product.
- 3.8. Any phone numbers provided for advertisement must be yours or you must have permission and authority to use such phone numbers.
- 3.9. Sellers must not post/submit illegal, prohibited or offensive content to the Preowned Platform and must not use derogatory terms on the Preowned Platform. - 3.14. Payment will only be made to the Seller after the sale of the goods.
- 3.15. Seller will receive the payment amount that was discussed at the time of filling out the listing minus the admin fee.
